## CWEA & WEF Purpose & Background

The California Water Environment Association (CWEA) is a non-profit, voluntary organization dedicated to the educational development of its members, and the dissemination of information concerning all aspects of the water environment industry.

CWEA is a Member Association of the worldwide Water Environment Federation (WEF). WEF is comprised of over 70 Member Associations and seven Operators' Associations.

With over 9,300 members and 17 Local Sections, CWEA is the largest Member Association in the Federation.

The Purpose of this Association is to enhance the education and effectiveness of California wastewater professionals through training, certification, dissemination of technical information, and promotion of sound policies to benefit society through protection and enhancement of the water environment.

## CWEA Membership Categories

Each of the following memberships include membership in one of CWEA's 17 Local Sections.

**Association:** Membership in CWEA, including one Local Section. Association members may join and hold office in Local Sections of the CWEA, may vote at CWEA level, but may not hold office at the state level, or vote or hold office at the WEF level.

**Active:** Membership in both the CWEA, including one CWEA Local Section and WEF. Active members are eligible to hold office in WEF, CWEA and its Local Sections and have full voting privileges.

**PWO:** Professional Wastewater Operations (PWO) membership is open to individuals who are actively involved, on a day-to-day basis, with the operation and maintenance of wastewater collection, treatment, and laboratory facilities. PWO members are eligible to hold CWEA, WEF and Local Section office and have full voting rights.

**Student:** For individuals enrolled at least half-time in an accredited college or university. Students must show proof of enrollment with their membership application. They may not remain student members after the calendar year in which their student enrollment ends. Student members are members of CWEA, WEF and one CWEA Local Section, but are not permitted to hold office. CWEA dues are complimentary.

**Corporate:** Corporate members are companies engaged in the design, construction, operation or management of water pollution control systems. Each Corporate member designates ONE representative who receives one individual membership in CWEA and one Local Section, 10% discount on all CWEA publications, 10% discount on first booth at Annual and first booth at Re-

**Retired:** Open to individuals who are retired from the wastewater industry, but wish to remain involved with and informed of CWEA and WEF activities and programs. Individuals may not hold this classification beyond the first anniversary date following re-employment and/or professional affiliation within the water environment field. Includes one CWEA Local

Section Membership.

**CWEA Utility:** Utility members are individuals employed by wastewater and water districts, utilities and agencies. Each Utility member designates ONE representative who receives one CWEA individual membership, one Local Section membership, 10% discount on all CWEA publications, and 10% off job listings on the CWEA website. Utility members may change their designated representative at any time, with written notice to CWEA. Only the designated representative has voting privileges.
